Jamie Raskin U.S. Representative (D-MD 8th District)

Congressman Jamie Raskin now represents Maryland's 8th Congressional District in the U.S. House of Representatives. Rep. Raskin is a returning Member of the House Judiciary Committee, the Committee on Oversight and Reform, and the Committee on House Administration. He is a new Member of the House Committee on Rules. Rep. Raskin is also Vice Chair of the House Administration Committee, Chairman of the Oversight Subcommittee on Civil Rights and Civil Liberties, and Vice Chair of the Judiciary Subcommittee on the Constitution. Rep. Raskin is the Caucus Leadership Representative for the 116th Congress. He was also appointed to serve as a Senior Whip for the 116th Congress. Prior to his time in Congress, Rep. Raskin was a three-term State Senator in Maryland, where he served as the State Senate Majority Whip.

Prior to politics, Rep. Raskin was the founding faculty adviser for the American University Legislation and Policy Brief, and co-founded the American University Washington College of Law's Program on Law and Government. Congressman Raskin earned his J.D. from Harvard Law School.
